PLEDGE TO ALLEGIANCE

Approval of Minutes

-Briggs moved, Everett seconded to approve the minutes from the Regular Meeting of July 12, 2016, Election Commission Meeting of July 12, 2016 and Special Meeting of July 25, 2016. Carried (4-0)

PAYMENT OF OPERATING BILLS:

-Cook moved, Everett seconded to pay the operating bills in the amount of \$51,737.98 drawn from the proper accounts. Carried (4-0)

CONSENT AGENDA:

-Everett moved, Briggs seconded to accept the Consent Agenda as presented. Carried (4-0)

FIRST CALL TO PUBLIC

Betty Blount stated that the Heavy Weight Horse Pulls had a great turn out with 16 Teams during the 2016 Festival Weekend August 4th-7th.

OLD BUSINESS:

Fence Ordinance- planning Commission amended their 2016 Meeting Schedule eliminating the September meeting date and scheduling a meeting and Public Hearing for August 29, 2016. The Public Hearing will be to consider a proposed amendment to section 152.075-Walls and Fences and Hedges and the addition of section 152.079 Plant Material. The proposed amendments and addition can be examined at the Reading City Hall during normal business hours or anytime on the City Website at http://reading.mi.us.

Resolutions for Proposed Charter Amendments have been sent to the Michigan Attorney General's Office and the Governor's office and we have received the recommendation from the AG's office to the Governor, just waiting for the letter of approval from the Governor's Office, prior to submitting to the County Clerk by August 16th to be placed on the November 8, 2016 Ballot.

NEW BUSINESS:

-Donihue moved, Briggs seconded to approve the change in standard street lighting to include switching the current Mercury Vapor to LED at a cost of \$833.54 and also to include the current high pressure sodium lights on Chestnut Street in from E. Cherry to Maple as well as the high pressure sodium on Strong from Michigan to Lincoln at an additional cost of \$4105.32.

-Everett moved, Briggs seconded to approve the bid from Wickham Tree Service in the amount of \$7800, less \$450 removing trees #4, 6 & 7 from the Maplewood East Side. Bid is to remove a total of 19 trees in Maplewood East & West Cemeteries.

-Briggs moved, Cook seconded to approve the proposal from Northern Pump & Well for the Cleaning of Well #7 on Dimmers Road in the amount of \$11,430. This proposal is to clean well #7 of the crustation of iron and mineral *deposits* on the screen by sonar jet and double disk cleaning with air.

-Donihue moved, Everett seconded to purchase a new salt spreader from Scientific Brake & Equipment Sales of Michigan in the amount of \$6375. This model is a stainless steel 4.5 cubic yard hopper spreader with a 14.5" wide conveyor chain and will also include a 44"LED Light Bar.
