FIRST CALL TO PUBLIC

Karen Scugoza was in attendance in regards to "Smart Meters" and asked Council if they had researched these meters as she had requested back at the April meeting and Mayor Donihue had shared that he had. Susanne Beard had stated that an individual property could opt out of the installation of these meters, but someone on a fixed income it could be a strain on their budget. Bonnie Thompson stated that she was surprised at some of the larger communities that had adopted resolutions to "opt" out of the installation of these smart meters.

Chuck Hartshorn, 223 Michigan had stated that he had received his utility bill for August and had a higher than normal water usage and after talking with his neighbor had felt that maybe someone had trespassed on his property and turned on his outside hydrant causing a higher than normal water usage. He would like to see law enforcement agencies collaborate better in regards to reported incidents in our town. Mr. Hartshorn also stated that a property on Michigan Street seems to have several families living in a single family dwelling and that the property is need of cleaning up. He also mentioned that someone had a canopy set up with an outside bar.
