# Old Business/OngoingBusiness 150 S. Main Street:

TIFA now owns the property and has received a copy of the title insurance as well as the deed. ### **106 Cherry Street:**

The Board discussed purchasing 160 Cherry Street for the purpose of turning it into a parking lot.

### **Industrial Park Properties:**

D. Berger shared that there was an inquiry from Sue Ditton on property for sale in Industrial Park. It was not mentioned what the intent of the property would be used for, medical marijuana or otherwise. The Board received a copy of the approved zoning amendments regarding medical marijuana. R. Sanders indicated that there is a covenant that was approved by the City of Reading, TIFA and other powers to be that over-rides any City ordinance, and the only way to change the covenant is by a vote of the members. The Board discussed available properties in the Industrial Park and decided to obtain a GIS map of the Industrial Park, a copy of the Declaration of Restrictions, a map of the TIFA District, and to discuss the issue during the regular TIFA meeting in March.
