### Old Business/Ongoing Business

150 S. Main-

-Newton moved, Everett seconded to accept proposals from prospective investors for the building at 150 S. Main with the possibility of matching funds up to \$90,000 to the prospective buyer for renovations to the building and to also publish a notice for the September 10, 2018 meeting to invite the public seeking their input on whether to renovate or demolish the building. Motion Carried (4-0)

Tabled the proposal for Administrative/Support Services between the City and TIFA until the September meeting.

#### New Business:

-Newton moved, Matthews seconded to approve the quote from LT Sealcoating in the amount of \$5030 to Sealcoat and Stripe the East & West Downtown Parking Lots. Roll Call Vote: Yeas- Everett, Newton, Matthews and Cleveland Nays- None Absent- Galloway, Gollnick and Sanders Motion Carried (4-0)

The Reading Planning Commission will set up a Public Hearing for an application to rezone 110 E. Silver Street. TIFA would like the property to be zoned commercial because the lot is contiguous to three lots that are facing Main Street and already zoned commercial.

-Newton moved, Everett seconded to authorize \$329 for the purchase of a mini computer for the Electronic Sign out by Enterprise Drive to help with transferring messages, and also to look into the possibility of the mini-computer to be installed in the N. Main Lift Station Building and also approval of up to \$150 for the purchase of a camera to be installed on the N. Main Street Lift Station Building to be able to view the sign for programming.

There was discussion in regards to signage for the Lots on the corner of S. Main and E. Silver Street. The thoughts are that the signage be large and will state that Commercial Property Available. We will hold off on the signage until after the Planning Commission Hearing on Tuesday, September 4<sup>th</sup> to determine whether the lot at 110 E. Silver will be re-zoned as commercial property.

The Board was informed that Crop Production Services has been changed to Nutrien Ag Solutions and that they had contacted City Hall in regards to changing their panel on the sign at Enterprise Drive. Nutrian Ag Solutions was given the information from Johnson Outdoor Digital on the cost for panel change and installation and they will take care of payment for this directly with Johnson Outdoor Digital.

Matthews stated that she will be late to the September Meeting, because she has another meeting that evening.
