The agreement is for the City to support the day to day functions and long term strategic goals of the TIFA.

Zoning of 110 E. Silver Street-The Planning Commission held a hearing on September 4, 2018 on an application from TIFA to rezone the property from R1 (Residential) to B2 (Downtown Business), the Planning Commission did approve a recommendation to City Council to amend the current zoning for 110 E. Silver from R1 to B2. The Council will meet on September 11, 2018.

Industrial Park Sign-Communications Upgrade-The City will be adding internet to the Electronic Sign on Enterprise Drive that should help with communications for programming the sign remotely.
