Approval of Treasurer's Report & Financial Statements

-Penney moved, Matz seconded to approve the Treasurer's Report & Financial Statements for April. Motion Carried (5-0)

Payment of Operating Bills

-Penney moved, Matz seconded to pay the operating bills in the amount of \$35,255.90 drawn from the proper accounts.

Consent Agenda

Briggs moved, Matz seconded to accept the Consent Agenda as presented. Motion Carried (5-0)

Guests: Mark Wiley, County Commissioner and Doug Sanford, Director Hillsdale County Emergency Services.

Mr. Wiley shared with the Council and Guests that the Commissioners Meetings will now be available for viewing on You Tube. He also shared that the Commissioners held their truth in Taxation Hearing earlier that day as part of their Commissioners Meeting. He also stated that the County is leasing form Enterprise County Fleet Vehicles to be used by Appointed and Elected Officials.

Mr. Sanford passed out brochures to the Council and Guests and also shared that there will be a county wide Special Election on Tuesday, August 6, 2019 for a request of a 911 Surcharge Renewal.

Public Hearing: Budget Hearing 2019/2020

Mayor Matthews called the Public Hearing, for the 2019/2020 Budget to order at 6:51 p.m. The Budget will propose the estimated expenditures and revenues. Also salary allocations and how it will affect each fund. TIFA's budget was also presented. The budget process also included the water, sewer and refuse rate schedules. There was a proposed 25% increase to the sewer monthly maintenance fee and no increase to the water and refuse rates. Discussion was held on the 2019 tax millage rate and the rate will stay the same 12.5302 mills. Misc. Rates Fee Schedule as well as the Cemetery Rate Schedule were included and there is no proposed increase at this

time. There was also discussion on TIFA's budget and discussion that the TIFA Capture percentage had gone up as there was an increase in TIFA's Taxable Value, although there was an overall decrease in the City's Taxable Value. TIFA's increase was due to improvements at The Anderson's as well as Nutrien Ag Solutions.

-Penney moved, Briggs seconded to adjourn the budget hearing. Motion Carried (5-0) Hearing adjourned at 7:24 pm

FIRST CALL TO PUBLIC:

Tracy Donihue thanked the Council for allowing the use of the Pulling Track on June 8, 2019 for the Antique Tractor Pulls. He said that the pull was very successful and that they had 106 Hooks, which was an outstanding turn-out for their first pull. They would like to hold the pull again in 2020, but are unsure of the date.
