NOTICE OF MEETING/PUBLIC HEARING OF THE CITY OF READING PLANNING COMMISSION BY ELECTRONIC REMOTE ATTENDANCE

Pursuant to the provisions of Executive Order No. 2020-154 issued by Governor Gretchen Whitmer, notice is hereby given that on Monday, September 14, 2020, the City of Reading Planning Commission will conduct its regular meeting/public hearing via remote electronic attendance. The meeting/public hearing will convene at 7:00 p.m.

The purpose of this Public Hearing is to consider application by Alvarez Cultivation, LLC for Signage at their property located at 137 S. Main Street. This property is located within the B-2 Downtown Business district, which is also located within the Historic Overlay District and exterior improvements are subject to the requirements of said district.

The meeting is being held via electronic remote attendance for the purpose of limiting the spread of COVID-19 (the novel coronavirus), and for the purpose of complying with Executive Order 2020-160, which limits indoor gatherings to no more than 10 people.

Those emailed written comments or questions submitted subsequent to 12:00 noon on September 14, 2020, but prior to the start of the live public comment portion of the meeting will be read aloud during the public comment portion of the meeting. Emailed written public comments or questions must not include language that would be considered vulgar or be interpreted as hate speech, fighting words, or that otherwise would be considered as out of order if the language were communicated verbally by the author at an in-person meeting of the Planning Commission.
