## NOTICE OF MEETING/PUBLIC HEARING(s) OF THE CITY OF READING PLANNING COMMISSION MEETING (Limited Seating)

Notice is hereby given that on Monday, June 7, 2021 at 7:00 p.m., the City of Reading Planning Commission will conduct its Regular Meeting/Public Hearing(s) in the Reading City Hall Council Chambers. This meeting will be open to the public and, any members of the public attending in person, will be required to follow the May 15, 2021 MDHHS Epidemic Order in regards to face covering (mask) wearing and maintain distancing of at least 6 feet. The Meeting/Public Hearing will convene at 7:00 p.m.

## Due to the size of the room there will be limited seating and seating will be first come, first served.

The City of Reading Planning Commission will hold public hearing(s) for the draft Master Plan and Capital Improvement Program (CIP) All persons are invited to attend. The proposed Master Plan is a public document that guides land use and development decisions for the city over the next 10 years. The CIP is a multi-year planning document that identifies the city's needs and financing sources for public infrastructure improvements. The draft can be found at <u>Reading-CIP-Draft.pdf</u>

Also, the City of Reading Planning Commission will be holding a Historic Overlay District Public Hearing. The purpose of this Public Hearing is to review plans for improvements to the building located at 126 South Main St. This building is located within the Historic Overlay District.

In addition, the City of Reading Planning Commission will also hold a public hearing to consider an application by Crystal Realty II, LLC/Frankfort Green LLC for a Special Land Use for the property located at 116 Enterprise Drive for a proposed Adult Use Marihuana Facility-Class C Grower under the City of Reading Marihuana Facilities Licensing Ordinances and applicable Zoning Ordinances regulating such facilities. This property is located within the I-2(Industrial Park) District.
