Tree Removal, Trimming and Stump Grinding

History/Information

The City of Reading has several old growth trees in our community that have been injured over the past couple of years from prior storms, wind and most recently the February Ice Storm, and need to be removed. This damage coupled with the trees age have made these trees a potential problem for the community.

Scope of work:

The city is accepting bids for the removal of these trees as well as the grinding of the stumps. The contractor will have to remove all brush from the site as well as stump grindings and stumps need to be ground to a depth of no less than 4 inches below existing grade. All wood may be left on site that is over 4", but anything 4"-20" should be cut no longer than 8' and anything over 20" should be no longer than 5'.

It will be the contractor's responsibility for all traffic control. Trees to be worked on are on the attached list.

Administrative:

The company shall provide the City of Reading an IRS form W-9 as well as certificates of insurance including workers compensation, general liability, and proof of insurance for all vehicles/equipment used under the contract agreement.

The company shall be in compliance with all federal and state laws regarding licensing, equal opportunity employment, and all other governing rules or regulations.

The City does not pay in advance of work. The contractor will be paid within 30 days of completion.
