To the qualified electors of THE CITY of Reading  
in THE COUNTY OF HILLSDALE, STATE OF MICHIGAN**

**PLEASE TAKE NOTICE** that any qualified elector of the above mentioned City who are not already registered, may register to vote at the office of the City Clerk, the office of the County Clerk, a Secretary of State branch office, or other designated state agencies. Registration forms can be obtained at [mi.gov/vote](http://mi.gov/vote) and mailed to the City Clerk. Voters who are already registered may update their registration at [www.expressSOS.com](http://www.expressSOS.com).

The last day to register in any manner other than in-person with the local clerk is **Monday, October 21, 2024.**

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at their Township or City Clerk’s office during regular business hours, special pre-election weekend hours, or on Election Day from 7:00 a.m. until 8:00 p.m., as follows:

You are hereby notified that a General Election will be held in all voting precincts in the County of Hillsdale, State of Michigan on Tuesday, November 5, 2024, at which time candidates of the Democratic Party, Republican Party, Libertarian Party, U.S. Taxpayers Party, Green Party, Natural Law Party, and Working Class Party and candidates without political party affiliation who seek election to the following partisan offices are to be voted for in your City or Township: President of the United States and Vice President of the United States, United States Senator, 5th District Representative in Congress, 35th District Representative in State Legislature, Member of the State Board of Education, Regent of the University of Michigan, Trustee of Michigan State University, Governor of Wayne State University, Prosecuting Attorney, Sheriff, County Clerk, County Treasurer, Register of Deeds, Road Commissioner, Drain Commissioner, Surveyor, County Commissioners (District three).

Candidates seeking election to the following nonpartisan offices are also to be voted for in the City at the November 5, 2024 General Election Justice of Supreme Court, Judge of Court of Appeals, Judge of Probate Court, City Council and School Board Members.

Absentee ballots are available for all elections; registered voters may contact the City Clerk’s Office to obtain an application for an absent voter ballot or online at [Michigan.gov/vote](http://Michigan.gov/vote)

To comply with the Help America Vote Act (HAVA), voting instructions will be available in audio format and in Braille. Arrangements for obtaining the instructions in these alternative formats can be made by contacting the City Clerk in advance of the election. All polling locations are accessible for voters with disabilities.
