MELS Project Updates-USDA Loan Resolution

-Matz moved, VanCamp seconded to approve the USDA Loan Resolution, authorizing and providing for the incurrence of indebtedness for the purpose of providing improvements to the City's Water System as part of the MELS Project.

This Loan Resolution is for the issuance of bonds in the principal amount of One million Six Hundred and Eleven Thousand. These are Revenue Bonds paid for through monthly water utility revenues.

USDA Loan-Cancellation of Funds

-Matz moved, VanCamp seconded to authorize City Manager to cancel the remaining \$589,000 of approved USDA funds that were not required for the completion of the MELS project. Motion carried (5-0)

These funds were originally approved when the City applied for funding with USDA for the MELS Project, but due to the breakdown of payers and construction bids lower than anticipated we are cancelling the additional \$589,000 of the funds obligated by USDA prior to closing on the loan.

Marihuana Ordinance #2019-01 & 02 Amendments Ordinance 2024-01

-Matz moved, VanCamp seconded to adopt Ordinance #2024-01 an ordinance to amend Ordinance 2017-01 of the City of Reading, as amended by Ordinance No. 2017-02, Ordinance 2018-02 and Ordinance No 2019-01 to amend Subsection 1 of Section III of the Ordinance, as amended, to change the maximum potential, number of Medical Marihuana Provisioning Centers that may be authorized by the City.
