READING CITY COUNCIL REGULAR MEETING Tuesday, August 12, 2025 City Hall Council Chambers

MAYOR PENNEY CALLED THE MEETING TO ORDER AT 6:30 P.M. AND LED THOSE IN ATTENDANCE WITH THE PLEDGE OF ALLEGIANCE.

ROLL CALL: George, Crank, and Penney present. Matz and Gary absent. Also present, Kimberly Blythe, City Manager/Clerk/Treasurer; Grace VanCamp, First Deputy Clerk/Treasurer/Zoning Administrator; Melani Matthews, Deputy Clerk/Treasurer/Cemetery Administrator; guest speaker, Abe Dane, Hillsdale County Clerk; Officer Eric Stolberg, Reading PD.

Guest: Chuck Hartshorn

Penney moved, Crank seconded to excuse Gary and Matz from the meeting. Motion Carried (3-0).

Crank moved and George seconded to approve the agenda as presented. Motion carried (3-0).

Guest Speaker Abe Dane updated council and guests as to what has been happening in the County Clerk's office and the courthouse.

- They have been busy getting records online for the public. These searchable and viewable records include vital records, such as births, deaths, marriages, DBA's, etc. as well as various applications, such as marriage licenses, notary applications, CPL applications, etc. Some of these things still require in-person visits to complete the process, but by having the applications online it should reduce the amount of time a person has to spend at the courthouse.
- The County Clerk's office is also responsible for putting together the jury pool for jury trials. This involves sending a questionnaire out to about 3,000 people. These questionnaires are then screened and sorted, putting groups of around 50 people into pools and assigning them to a 3-month span of time in which they may be called to serve.
- Early voting is also handled at the courthouse. The last national election saw a turnout of over 77% and out of these, 19% voted early. All voting municipalities in the county are in an agreement and share the cost of early voting.
- Circuit court is held in the courthouse. Last year, they had 335 domestic hearings (divorce, custody, etc.), 103 civil cases, reviewed 261 applications for Personal Protection Orders, and had 210 criminal cases.

This is a broad overview of some of the things handled by the County Clerk's office. Abe asked if there were any questions – Kym asked if there had been any proposal language submitted for the November election – and there hasn't been any for Reading.

PUBLIC HEARING

Penney closed the regular meeting and opened the Second Street vacation public hearing at 6:45 P.M. Second Street was originally platted when the streets were planned

in 1873. The proposed street has never been developed. Further, since the original plans were made, multiple properties now have homes on them, and developing a street in that area no longer makes sense as it would go right through those houses and/or garages. By removing the street from the plans, it will eliminate any confusion for future development. Essentially, there is no room for a street to go there. Penney moved, Crank seconded to close the public hearing. Motion carried (3-0). Public hearing closed and regular meeting resumed at 6:51 P.M.

OLD/ONGOING BUSINESS MELS (Michigan/East/Lynn/Strong) Project Updates

- Strong St
 - Concrete curb and gutter and sidewalk installation dates have been dynamic. Yesterday the concrete subcontractor notified us that he is available this Thursday the 14th to install curb and gutter. This will be followed by sidewalk Friday the 15th.
 - Asphalt Paving will follow concrete work and is scheduled to begin on Tuesday, August 19th.
- Michigan St
 - Water services are largely complete
 - Resubmittal to MDOT with additional requested information before Monday the 18th.
 - Preconstruction meeting with MDOT and others engaged by MDOT for RR crossing work to be August 22nd. Coordination of MELS and MDOT project to take place during this meeting and the intent is to coordinate such that jack and bore of water main carrier pipe can be omitted. In lieu of jack and bore open cut trench water main installation would be performed.
