**NOTICE OF PUBLIC ACT 57 INFORMATIONAL MEETING/REGULAR BOARD MEETING OF
THE CITY OF READING TAX INCREMENT FINANCE AUTHORITY
BY ELECTRONIC REMOTE ATTENDANCE**

Pursuant to the provisions of Executive Order No. 2020-75 issued by Governor Gretchen Whitmer, notice is hereby given that on Wednesday, June 10, 2020, the City of Reading Tax Increment Finance Authority will conduct its public hearing/regular meeting via remote electronic attendance. The hearing/meeting will convene at 6:45 p.m.

The PA 57 Informational Meeting/Regular Board Meeting is being held via electronic remote attendance for the purpose of limiting the spread of COVID-19 (the novel coronavirus), and for the purpose of complying with Executive Order 2020-96 issued by Governor Whitmer, which prohibits, “all public and private gatherings of any number of people occurring among persons not part of a single household,” and which further suspends, “[a]ll in-person government activities at whatever level (state, county, or local) that are not necessary to sustain or protect life, or to supporting those businesses and operations that are maintaining in-person activities under this order.”

The PA 57 Informational Meeting will be the first of two public informational meetings for 2020 and will be to share with the public upcoming projects and plans for the 2020/2021 Fiscal Year as well as sharing current projects for the Reading Tax Increment Finance Authority for the 2019/2020 Fiscal Year.

Those emailed written comments or questions submitted prior to 12:00 noon on June 9, 2020 will be copied and included in the agenda packet for the meeting. Those emailed written comments or questions submitted subsequent to 12:00 noon on June 9, 2020, but prior to the start of the live public comment portion of the meeting will be read aloud during the public comment portion of the meeting. Emailed written public comments or questions must not include language that would be considered vulgar or be interpreted as hate speech, fighting words, or that otherwise would be considered as out of order if the language were communicated verbally by the author at an in-person meeting of the Board.
