**NOTICE OF MEETING/PUBLIC HEARING OF THE CITY OF READING  
PLANNING COMMISSION BY ELECTRONIC REMOTE ATTENDANCE**

Pursuant to the provisions of Executive Order No. 2020-129 issued by Governor Gretchen Whitmer, notice is hereby given that on Monday, July 13, 2020, the City of Reading Planning Commission will conduct its regular meeting/public hearing via remote electronic attendance. The meeting/public hearing will convene at 7:00 p.m.

The purpose of this Public Hearing(s) is to consider applications by BRT Capital 3, LLC for a Special Land Use for the property located at 112 S. Main Street for a proposed Marihuana Establishment-Retailer under the City of Reading Marihuana Establishments Ordinance and applicable Zoning Ordinances regulating such facilities. This property is located within the B-2 Downtown Business district. This property is also located within the Historic Overlay District and exterior improvements are subject to the requirements of said district.

The meeting is being held via electronic remote attendance for the purpose of limiting the spread of COVID-19 (the novel coronavirus), due to the lack of availability of a facility large enough to accommodate the anticipated number of attendees of the meeting and still comply with applicable social distancing guidelines and requirements.

Emailed written public comments or questions must not include language that would be considered vulgar or be interpreted as hate speech, fighting words, or that otherwise would be considered as out of order if the language were communicated verbally by the author at an in-person meeting of the Planning Commission.
